

Charges at a glance – United Utilities wholesale area

This is a brief summary of the primary water and sewerage main charges for customers in the United Utilities wholesale area from 1 April 2024.

From 2023 onwards, the charges applied to your site on a deemed contract will be different depending on the total level of consumption you use as a customer. Where you have multiple sites, the consumption for each of these sites will be added together for the purposes of defining customer group.

The 3 customer groups are defined by usage between 0 - 500 m3, 500 - 50,000 m3 and usage greater than 50,000 m3 respectively. An additional retail fee will be applied to sites, detailed in table 1.
